





Only North Sea haddock caught by vessels in the manner defined in the Units of Certification under restrictions detailed throughout the body of the Public Certification Report (July 2012) for this fishery shall be eligible to enter the chain of custody. Chain of Custody should commence following the first point of first sale at which point the product shall be eligible to carry the MSC logo. There are no restrictions on the certified product entering further chains of custody. The DFPO Denmark North Sea & Skagerrak haddock fishery does not require its own chain of custody certificate.
