Management System: Denmark is a member of the EU and fisheries policy and management within EU member states is carried out according to the EU Common Fisheries Policy (CFP). Implementation of the CFP at a national level is carried out through the individual Member States. In Denmark responsibility for fisheries management, legislation and policy lies with the Ministry of Food, Agriculture and Fisheries (established by Royal Decree in December 1996). The main Danish enabling legislation is the 1999 Fisheries Act (Act No. 281 of 1999, consolidated as LBK No. 978 of 26 September 2008), which makes provision for the management of fisheries for purposes of protection and enhancement of living resources in marine and freshwater and for the protection of other marine animal and plant life, to safeguard the basic foundations of commercial fishing and related commercial activities and sport fishing.

Chain of Custody: The limit of identification of landings from this fishery is to the first point of sale, whereupon fish and fish products may enter chains of custody.

DFPO Denmark North Sea & Skagerrak Plaice Fishery Client Companies Authorized to Sell MSC Certified Plaice (European): DFPO registered vessels targeting the European Northern plaice stock that have signed up to and fulfill the requirements of the DFPO Code of Conduct.
